The OPSC Plan Verification Team (PVT) and its reviews of project application submittals for State funding is one of the more critical first steps in the School Facility Program process - the review impacts almost every funding application, including new construction projects on existing school campuses. This workshop will provide an in-depth review of the PVT process, including:

- An overview of additional/supplemental grants available to school districts
- A discussion of common submittal errors and how to avoid them
- A discussion on preparing appropriate project cost estimates for a speedy PVT review
- Anecdotes from the field - real-life district experiences with the PVT and tips on how to prepare for the PVT review
