

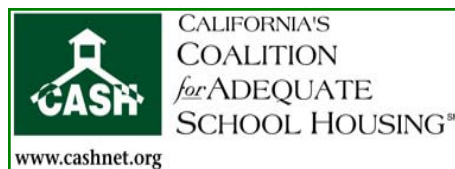
About C.A.S.H.
