

**RESOLUTION #06-14**

**RESOLUTION OF THE BOARD OF TRUSTEES OF THE  
OXNARD SCHOOL DISTRICT IN SUPPORT OF THE  
NOVEMBER 7, 2006, STATE BOND FOR SCHOOLS  
(PROPOSITION 1D)**

WHEREAS, California's public schools face severe overcrowding; and

WHEREAS, more than 60 percent of California's schools are 25 years of age or older and require major repairs; and

WHEREAS, the State Architect has identified more than 7,000 school buildings that could need upgrades to be earthquake safe; and

WHEREAS, adequate educational facilities are critical to preparing students for the workplace and high wage jobs; and

WHEREAS, the State estimates that the need to build new schools and repair older schools totals more than \$11 billion over the next five years; and

WHEREAS, the backlog of school district applications awaiting funding to repair old schools exceeds \$400 million and is growing monthly; and


WHEREAS, our community colleges, state universities and college and university systems need additional funding to build new classrooms and repair older facilities; and

WHEREAS, Oxnard School District has put on the November 7, 2006 ballot a Bond measure for the construction of additional schools;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Oxnard School District supports passage of a K-12/Higher Education statewide bond measure for the November 7, 2006 ballot.
